ELIGIBILITY

Ordinary Corporate/ Institutional Member

Ordinary Individual Member

Any individuals who are Malaysian citizens or non-citizens in Malaysia and who are in a mid-level or above leadership position with professional experience and with a successful track record in business and economic affairs.

Associate Member

Any non-commercial entities registered in or operating in Malaysia and to individuals working in Malaysia

Entrance Fee and Subscription

All Members have to pay a one-time entrance fee.
